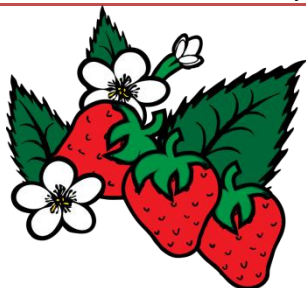

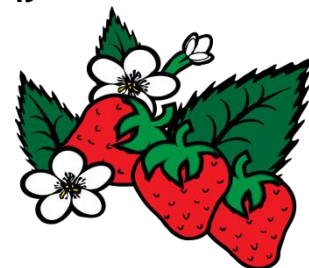

2016.2017 Non Disc Statement
